In addition, if your countertop cut-out depth is less than 24" and removal of your old range reveals uneven or slightly damaged edges on the sides of your countertop cut-out, Whirlpool will provide a set of two (2), (each ½ inch wide) trim pieces which are designed to cover up to ½ inch of the side edges of your countertop cut-out.   - iv) a dated invoice or receipt from a professional installer or contractor stating the cost to modify your existing countertop cut-out.

Retain a copy of all documents for your records. Allow 8 weeks from the date your claim form is mailed for delivery of claim payment.
